#### 2024 Chief's Summary

In 2024, felony investigations remained relatively consistent with 45 felony level reports in the village (24 theft related offenses, 6 fraud/forgery, 4 sex offenses, 2 burglary/breaking and entering, 1 disrupting public service, 1 domestic violence, 1 drug offense, 1 fleeing/eluding, 1 intimidation of a witness, 1 misuse of 911, 1 robbery, 1 vandalism, 1 strangulation), excluding 4 felony warrant arrests. This is up from 37 felony level offenses in 2023.

In February, Caden Mosher successfully completed the North Central State College Police Academy after being selected as the agency's first sponsored "Recruit". His attendance at the academy was funded via a recruitment and retention grant that allowed the village to pay the academy tuition costs of approximately \$8,500. Mosher, who started with the department as an explorer/cadet and was later promoted to cadet captain, was sworn in as a full-time police officer in March and assigned as a cadet advisor shortly thereafter.

In May, the department implemented the use of body cameras. The cameras were purchased through a grant by the Ohio Office of Criminal Justice Services in the amount of \$11,835 and have proven themselves to be a vital piece of equipment that not only provides unparalleled evidentiary value but also protects officers from false or frivolous complaints.

In June, the department transitioned from the less functional, traditional "Class B", uniforms to customized outer carriers that provide options for removing some equipment from the belt while also providing increased visibility. The vests and equipment were purchased via a grant from the Ohio Law Enforcement Body Armor Program with an award of \$10,736.68.

The 2022 Dodge Durango patrol vehicle received modifications and was assigned as the K9 cruiser. Part of the costs associated with the upfitting, \$5,000, was paid for with a donation from the Central Ohio Canine Foundation. A new 2023 Durango was purchased and upfitted as a patrol cruiser. The 2016 Ford Explorer was retired and auctioned.

In December, Mount Gilead Village Council approved a request for an additional full-time officer that would support a dedicated detective position. After careful consideration, Sergeant Chase Beekman was chosen to fill the assignment, starting in 2025.

My goals for 2025 continue to be training that aligns with the department mission and supports each individual officer to better serve our community. We will continue to provide professional and proactive law enforcement services to the citizens and visitors of the Village of Mount Gilead.

#### **2024 Staffing Summary**

The department began the year with seven full-time officers: Chief Adam Lakey, Captain Thomas Cronenwett, Sergeant Chase Beekman, Officer Micheal Turner, Officer Jessie Brady, Officer Jason Robinson, and Recruit Caden Mosher who was attending the North Central State College Police Academy.

The department began the year with three part-time officers: Officer George Hinkle, Officer Jeffrey Cline, and Officer Frank Ramos.

On January 15, Officer Jessie Brady resigned to accept a position with the Marion County Sheriff's Office.

On March 7, Officer Caden Mosher changed classification from Recruit to full-time patrol officer upon completion of the police academy and becoming certified by the State of Ohio.

On April 4, Officer Scott Sanford was hired as an auxiliary officer. Sanford retired from the Powell Police Department and previously worked as a deputy with the Wood County Sheriff's Office. He brings with him over 28 years of law enforcement experience.

On May 22, Officer Aaron Gattshall was hired as a full-time patrol officer. He is a recent graduate of the Marion Law Enforcement Academy.


On May 22, Officer Ethan Lichtenberger was hired as a part-time patrol officer. He is a recent graduate of the Marion Law Enforcement Academy.

As a result of the new hires, Sergeant Chase Beekman spent in excess of 15 weeks assigned as a Field Training Officer.

In December, Village Council approved a request for the department to hire an additional full-time officer to allow for a full-time Detective assignment in 2025. After careful consideration, Sergeant Chase Beekman was selected to fill the assignment.

The Law Enforcement Cadet Program ended the year with three Cadets: Cadet Robert Copeland, Cadet Jimmy Hardy, and Cadet Cody Huffine. The Cadets assist with parade details, attend monthly trainings, and participate in ride-a-longs. In 2024, the Cadets volunteered in excess of 207.5 hours.

## Patrol Operations 2024 Summary

In 2024, Officers responded to 1,576 calls for service, investigated 228 offense reports, handled 79 crashes, conducted 1,818 traffic stops, issued 1,412 warnings, performed 4,395 foot-patrols, and issued 647 charges to 505 persons. The youngest person charged was 13 and the oldest person charged was 90.

In addition to patrolling the Village, officers carried out many valuable communities service functions such as: 121 assists for other agencies, 104 vehicle lockouts, 40 Fire Department and Emergency Medical Service assists, and attended numerous public relations events.

A call for service is anytime an officer is requested for help.

A report is taken whenever there is a criminal offense requiring investigation or documentation, or a death.


A crash report is taken for crashes that occurred on the roadway or crashes on private property resulting in injury or significant property damage.

A traffic stop is anytime an officer contacts a motorist for a violation of law.

A foot-patrol is anytime an officer is out of the car to check a business or residence or interact with citizens for no reason other than to socialize or verify that the building is secure.

A charge is a citation, complaint, or warrant issued for a criminal offense.


#### Patrol Operations Zone Map




The Village of Mount Gilead is divided into 5 "Zones" for statistics and tracking purposes.


- **Zone 1 = North of High Street, West of Main Street**

#### Patrol Operations 2024 Calls for Service





#### Patrol Operations 2024 Calls for Service










## Patrol Operations 2024 K9 Statistics




The department currently has one Canine Officer, K9 Major Niko.

The K9 team was responsible for 3 drug finds in 2024.











#### Patrol Operations 2024 Officer Activity
